## DESCRIPTION OF RESEARCH, TEACHING, AND SERVICE INTERESTS

My research program focuses on applied macroeconomics and monetary economics, with special emphasis on international and open economy issues. Most of my work is concerned with empirical analyses of policy-related questions, often in the context of cross-country comparisons, and pays close attention to methodological issues associated with the use of macro data. Early work, which culminated in the publication of my sole-authored book, investigates alternative schools of macroeconomic thought in the context of an open economy. Since then, my research agenda has evolved along three broad and overlapping paths. My published work on *monetary policy issues* examines the effects of monetary policy under different exchange rate regimes, the information content of interest rate spreads for economic activity, and the stability and specification of the money demand function. In a series of papers, my co-author and I also investigate the characteristics and macroeconomic effects of inflation uncertainty. A second strand of research seeks to inform the policy debate about economic development issues. One highly cited article examines the link between exchange rate volatility and trade; another tests hypotheses about big push industrialization and coordination failures to provide empirical evidence on underdevelopment traps and the role of government policy in developing countries. Current work investigates the link between financial inclusion and monetary policy in the developing world. My third research area focuses on topics in *economic and monetary* integration, with published papers on dollarization in Latin America, enlargement of the Eurozone, and seigniorage distribution among Eurozone countries. Other work analyzes the role of transportation costs for the "band of inaction" around purchasing power parity.

My teaching interests and responsibilities in the economics department complement my research portfolio and include courses in macroeconomics, money and banking, international trade, and international finance. As one of only two faculty members specializing in macroeconomics, I have been heavily involved in teaching our core undergraduate and graduate courses in this area. I thoroughly enjoy teaching and interacting with students inside and outside the classroom. In my classes, I strive to promote active learning by providing my students with opportunities to *do* economics and apply the tools of economic analysis to current issues. Student evaluations and my teaching awards (2011-2013 Presidential Teaching Fellow, 2008-2009 Outstanding Teacher of the Year) indicate that I have been a highly effective and respected teacher. Graduate as well as undergraduate students have sought me out for academic advisement and direction in teaching and research. In the past, I have sponsored student participation in professional meetings by organizing student research sessions. I have also played a crucial role in several important curriculum changes (e.g., new undergraduate course sequence in international economics, new undergraduate topics course in macroeconomics, overhaul of graduate (macro-) theory courses, creation of new graduate field in international/development economics).

As director and associate director of the International Studies Institute (ISI), I have been involved in the development, organization, fundraising, and administration of an interdisciplinary UNM study abroad summer program held in Germany since 2008. Taught in English by UNM faculty from different departments, the program gives students an opportunity to explore a given theme through two related courses that combine classroom instruction with field trips and guest lectures. I have also overseen the tremendous growth of the International Studies major, serving as the instructor of record for our two capstone courses for 2010-2013, evaluator of capstone projects since 2013, outcomes assessment coordinator, and primary faculty advisor.

My service program is diversified and has grown with my professional experience. I have served actively and effectively on numerous committees at the department, college, and university levels. In addition, I have taken on administrative duties as the director (2005-2006, Spring 2008, 2008-2013, Fall 2017) and associate director (2013-2017, Spring 2018) of the ISI. In the profession, I have served as a referee for academic journals, reviewer for publishers, discussant at professional meetings, and reviewer for other universities. My community service includes invited lectures to various local groups as well as media interviews about current economic events. I have also been a past member and chair of the executive board of the Albuquerque Committee on Foreign Relations.
