ECONOMICS GRADUATE PROGRAMS

- Master's and PhD programs are available
- Deadlines for these programs are typically early in the spring semester, but dependent on the school and spots available
- Typical application requirements:
 - Graduate school application
 - Graduate Record Exam (GRE)
 - 3 letters of recommendation (preferably from faculty)
 - Letter of intent
- Strong math background is beneficial
 - Second major or minor in Mathematics or Stats
- MATH321 Linear Algebra is a good class to prepare for Economics graduate programs

MPA SHARED CREDIT PROGRAM

- Apply to the ECON/MPA shared credit program at the end of junior year
- No GRE exam required
- Start taking PADM courses fall semester senior year
- Graduate with Public Administration minor in spring semester with Economics degree
- Graduate with MPA one year after graduating with Economics degree

MBA 3-2 PROGRAM

- Apply by March 1 during junior year for the program
- Must have GRE or GMAT taken before March 1 deadline
- Have MBA 3-2 form completed by advisor proving student only needs 12 credit hours outside of MBA coursework to meet graduation requirements
- Take 9 credit hours of MBA coursework in Fall and Spring semesters of senior year
- Graduate with Management minor with Economics degree
- Graduate with MBA one year after graduating with Economics degree

MASTER OF PUBLIC POLICY

- The Master of Public Policy (MPP) program will train a new generation of analysts who can serve their communities by identifying and championing data-driven policy options
- MPP graduates will contribute to improved decision making in locate and state government agencies, in Native communities, and in the private and non-profit sectors
- Application requirements:
 - GRE test scores (waived for Fall 2021)
 - Letter of Intent
 - Writing Sample
 - Resume
 - MATH1350 only required course
 - 3 letters of recommendation

LOBOTRAX AUDIT

University Requirements:

- A&S pre-admission requirements
- Admitted to your Major (congratulations!)
- 120 hours minimum
- Residency
 - 30 hrs minimum @ UNM, 15 of those hrs after 92
 - 50% of major completed at UNM
 - 25% of minor completed at UNM
- Second major or minor is needed to graduate with ECON degree



LOBOTRAX AUDIT

University Requirements Continued:

- 2.0 GPA (Over 3.0 if considering grad school)
- English 1120 (or equivalent)
- General Education Curriculum
 - Must complete all 7 areas
 - C or better (not C-)
 - Specific courses only (List)
 - Gened.unm.edu

LOBOTRAX AUDIT

College Requirements:

- 90 A&S hours need to watch electives if minoring outside A&S
- 48 hrs 300+
 - 4th semester of a foreign language = 6hrs toward upper division
- A&S 120
 - Could be different than University 120
 - Limited hours in certain courses
 - PE-NP (4)
 - Ensemble Music/Dance (4)
- A&S Residency (12 hrs)



ECON MAJOR REQUIREMENTS

Requirement: 33 credit hours of ECON coursework (not including MATH1350, MATH1430 or 1512) *ECON307 could be taken instead of MATH1430 or MATH1512, to count in both A&S upper division and ECON major electives


1) The following Economics core courses required: ECON 2110, 2120, 300, 303, 309

2) 3 Hours minimum from the following 400 level courses: ECON 403, 407, 408, 409, 410, 421, 423, 424, 427, 429, 442, 445, 466, 478


3) 15 Hours of ECON Electives – with a maximum of 3 Hours from the 2000 level

ECONOMICS: REQUIRED COURSES

Require Courses in Orange Boxes, Pre-reqs in Blue Boxes



Plus 3 hours 400 level ECON (See LoboTrax for allowable courses)



THE 400 LEVEL COURSE

- Pre-requisites vary. All require at least 300 or 303 or 309 (or a combination of these)
- Must take at least one in order to graduate
- Advanced Material, Projects, Writing
- Capstone Experience
- Higher order thinking, problem solving

INDEPENDENT STUDY

Economics 451 with Faculty Sponsor

- Does **NOT** count for 400 level course requirement
- Can count in major electives
- 1-3 Credits, depending on hours worked for organization
- Pre-Reqs: 300, 303, 309

Economics majors are encouraged to participate in internships with private firms, non-profit organizations and government agencies. An internship provides students with practical experience and the opportunity to apply economics concepts and skills to real world problems.

Students are responsible for finding their own placements (Career Services can help!) and prior approval from the Undergraduate Director/faculty is necessary before registering for the course.

REQUIREMENTS:

- Depends on how many credit hours you are earning
- Faculty with whom you are working will outline specifics, but research and assignments will be required in addition to your internship participation

DEPARTMENTAL HONORS:

- Opportunity for undergraduate research experience
- 3.2 Overall GPA (not just in the major)
- Faculty Sponsor
- Two semester Sequence *in addition to 33 hour major requirements*
 - Econ 498 Reading for Honors (3 credit hours)
 - Econ 499 Honors Thesis (4 credit hours)
